Government breaks new ground with revised Online Safety Bill

The latest version of the Online Safety Bill was introduced in the UK's Parliament on 16 March 2022. It now begins the process of being scrutinised, amended and debated on but it is anticipated that this is the version that will ultimately be passed and made into law in the UK. What does this mean for the technology sector, especially those offering online user-to-user services and online search services in the UK, and abroad? If passed in its current form, the Bill will create what the UK government claims is a world-first online safety regulatory framework – backed up by sanctions, including heavy financial penalties and new criminal offences, marking a significant

change for certain online businesses. Senior managers will be handed responsibility for overseeing compliance with the regulator's requests for disclosure and subject to potential criminal sanctions, where they fall short, and the Bill will result i...
