BIOGRAPHY

Joe has litigated more than 75 IP cases representing clients in district courts throughout the United States, as well as at the U.S. Court of Appeals for the Federal Circuit. He has also represented clients in more than 100 post grant proceedings at the United States Patent and Trademark Office, including Inter Partes Review and Post Grant Review proceedings. Joe has extensive experience representing clients in ex parte reexaminations and reissue proceedings, as well as assisting clients with various other post-issuance procedures, such as certificates of

correction. Joe also frequently works with clients on patent portfolio development and management strategies to maximize the protection and value of their IP assets.

EXPERIENCE

- *Schwendimann, et al. v. Neenah, Inc. and Avery Products Corporation* (D. Del. & E. D. Mich.)
Representing defendants Neenah and Avery in a multi-district patent infringement case related to image transfer paper. Successfully invalidated seven of the eight asserted patents through IPRs at the Patent Office, which resulted in the cases against all but one defendant being dismissed with prejudice. Continue to defend Neenah against the sole asserted patent remaining in the lawsuit.
- *Innovative Solutions and Support, Inc. v. J2, Inc., et al.* (W.D. Tenn.) Represented plaintiff, Innovative Solutions and Support, Inc., in patent infringement and trade secret case related to

aircraft computers. Obtained a judgment for the client in excess of \$24 million, including attorneys' fees.

- *Netscape Communications Corp., v. ValueClick, Inc. et al.* (E.D. Va.) Represented the defendant, a provider of online advertising services, against allegation of infringement of U.S. Patent 5,774,670, which is commonly referred to as the “cookie” patent in the Internet field. Our efforts led to the invalidation of the independent method claim and the dismissal of allegations of willful infringement on summary judgment.
- *Acco Brands, Inc. v. Belkin, et al.* (E.D. Tex.) Successfully defended Belkin in a patent infringement case through two jury trials in the Eastern District of Texas and an appeal to the Federal Circuit. Three patents related to computer locks were asserted, one patent was dismissed on summary judgment, another claim was dismissed by JNOV after trial, and the third claim was dismissed after an appeal to the Federal Circuit.
- *Firepass IP Holdings, Inc. v. The Boeing Company* (E.D.N.Y.) Defended The Boeing Company against claims of infringement of several U.S. Patents relating to fire suppression systems for aircraft.
