## **BIOGRAPHY**

He held the lead staff responsibility for major aviation and surface transportation reauthorizations, fisheries and marine environmental policies, energy development and regulation, technology policy, and homeland security, among others. Mr. Russell is equally at home in both the authorizing and appropriations arenas and has extensive experience with the Senate confirmation of presidential appointees, congressional committee hearings, and Senate floor procedure.

Since joining the firm, Mr. Russell has drafted and helped enact federal legislation, successfully created legislative history, obtained emergency federal permits, negotiated the closure of duplicative federal programs, secured federal funding for clients' projects, and guided clients through complex administrative, legislative, and political predicaments.
