She is a former Thurgood Marshall Award winner from the New York State Bar Association in recognition of her pro bono work on behalf of a death row inmate in Tennessee, and a Thomas L. Sager Award recipient by the Minority Corporate Counsel Association for creation of a successful diversity initiative with a client company.
