EXPERIENCE

- Representation of international food manufacturer and brand owner against claims that products were misleadingly labeled and falsely advertised because food packaging contained per- and polyfluoroalkyl substances, also known as PFAS, which allegedly migrated into food products. Successfully obtained plaintiff's pre-answer withdrawal of breach of warranty and negligent misrepresentation claims and pre-answer dismissal of public injunction request.
- Successfully negotiated resolution of individual plaintiff's claims in the District Court for the District of Massachusetts alleging employer, leading manufacturer of industrial and architectural acoustic sound control protocols, violated FLSA and Massachusetts wage and

Back to Work: California's Blueprint for a Safer Economy

On August 28, 2020, Governor Gavin Newsom unveiled a new plan for the reopening of California's economy following the closures ordered in response to the COVID-19 pandemic, which replaced the county watch list system that was previously in effect. The new plan provides for a four-tier system in which counties must show consistent progress in reducing the transmission of the coronavirus before allowing for greater flexibility in the reopening of businesses, schools, and resuming group activities. The stated intent of the plan is to be "statewide, stringent and slow," and to impose uniform limits on what businesses can be open depending on a county's infection rates.
