Dual-qualified to practice in France and New York, Aymeric's clients include publicly-listed and privately-held companies, international financial institutions and corporate executives facing criminal, regulatory or parliamentary investigations, often related to national security concerns. His reputation as a trusted advisor to his clients has resulted in recognition by Legal 500 EMA 2023 and among the '40 Under 40' by Global Investigations Review. He is also part of the team behind the creation of the White-Collar Crime Young Practitioners (WCCYP) association and regularly speaks and writes on topics related to his practice.
