Through this transaction, EW GROUP, an international family-owned holding company comprising more than 300 subsidiaries and operating in the sector, intends to accelerate and support Olmix's positive growth trajectory, with Olmix expected to remain an autonomous company within EW GROUP, alongside EW Nutrition.

Based in Bréhan, Brittany, Olmix is an international group specialized in the development, production and distribution of high-value-added bio-based solutions for the livestock and crop sectors. Through its range of finished products and ingredients, Olmix is a trusted partner for breeders, farmers, distributors and agri-food industry players worldwide, supporting smart and sustainable agriculture.

The transaction would also mark the exit of Motion Equity Partners, which invested in the company as part of an LBO in 2020.
