BCLP RELOCATES TO NEW OFFICE IN FRANKFURT, SIGNALING CONTINUED GROWTH AND INVESTMENT IN GERMANY

BCLP announces today that it will move its Frankfurt office to the Junghof complex in the Goetheviertel district, where it is expected to occupy approximately 2,900 square metres. The firm anticipates that the move will be completed in late 2027.

The new Junghof office offers modern, flexible workspace within an eight-story complex which includes 22,000 square metres of office space, 1,200 square metres of retail and dining areas, a client lounge, terraces and a landscaped courtyard. The building is LEED Gold certified and designed to support collaboration, wellbeing and sustainable working practices.
