BIOGRAPHY

Prior to coming to the firm, Mr. Ipsen was an Assistant Attorney General representing the State of Washington Department of Ecology and following that was the chief water enforcement attorney in

the U.S. Environmental Protection Agency's Region VIII office in Denver, establishing and directing the Region's water enforcement program under the federal Clean Water Act. He has spoken extensively on Clean Water Act enforcement and has authored numerous articles on that subject.

Mr. Ipsen's abundant experience in regulatory enforcement includes federal and state administrative and judicial enforcement actions under the federal Clean Water Act, Resource Conservation and Recovery Act, Atomic Energy Act, and the Clean Air Act and state counterpart statutes. He has substantial experience litigating CERCLA enforcement, allocation and natural resource damage actions in the federal courts. Mr. Ipsen has been involved in a large number of administrative and judicial appeals of federal and state licensing actions under the Clean Water Act, Atomic Energy Act, Resource Conservation and Recovery Act, and state counterparts.
