## PATENT AND OTHER INTELLECTUAL PROPERTY LITIGATION

- Represent consumer electronics company in successful patent infringement lawsuit filed against two competitors, resulting in final judgment in client's favor including permanent injunction. We obtained summary judgment that the accused products infringed our client's patent, and summary judgment disposing of the defendants' patent invalidity defense based on alleged anticipation. We also obtained favorable *Daubert* rulings striking portions of the other side's technical expert and damages expert reports. The defendants ultimately consented to the Court entering a final judgment in our client's favor including findings of patent validity, infringement, a monetary award, and a permanent injunction prohibiting the Defendants from selling importing or selling the infringing devices.
