- Ware v. Jewel Food Stores (U.S.D.C. for the Northern District of Illinois) Won summary judgment on claims of disability discrimination (discharge) and failure to accommodate
- Crawford v. Security First Group (U.S.D.C. for the Southern District of Iowa) Won jury trial.

- Whittier v. Metropolitan Life Insurance Company (U.S. Court of Appeals for the Sixth Circuit) –
   Court of Appeals upheld favorable arbitration award
