#### NSIP Reforms: New pre-application procedure and document requirements

As part of the ongoing Government reforms to the consenting process for Nationally Significant Infrastructure Projects ("NSIPs"), PINS has launched its 2024 Pre-Application Prospectus. The Prospectus sits alongside a suite of other newly-published Guidance, which we have discussed in previous Insights, providing updated guidance on the DCO pre-application stage and new guidance on the new Fast-track process. The Prospectus implements expected reforms to the NSIP application process and provides important detail which all promoters should familiarise themselves with. In this Insight we summarise the key changes, which includes a: new tiered Preapplication service and associated costs; new and increased documentation and procedural requirements; Fast-track procedure; and transitional arrangements for projects already in the system.
